## Emperador acquires new vineyard land, prepares to enter new market

Emperador International, Ltd., through its Spanish subsidiary Grupo Emperador Spain S.A., has acquired today another 409 hectares of vineyard land within the province of Madrid, Spain. Jorge Domecq Bohórquez, managing director of Emperador International, said: "We are building more vineyards in order to support our brandy production in Spain. We are very satisfied with the Philippine market's reception for our Emperador Deluxe Spanish Edition, an Emperador product that is produced and bottled in Spain.
